MEMORANDUM OF UNDERSTANDING

Between

Government College for Women, Hisar

And Sakhi Makeovers Beauty Parlour, Hisar

1. PURPOSE

The purpose of this MoU is to establish a collaborative relationship between GCW Hisar and Sakhi Makeovers to provide practical training, skill development, and internship opportunities to students in the domain of beauty and wellness under value-added or skill-based courses as per the National Education Policy (NEP) 2020.

2. OBJECTIVES

The specific objectives of this collaboration are:

- To provide hands-on training in beauty, makeup, skincare, hair styling, and related
- To enhance employability skills of students through exposure to real-time work
- To organize workshops, seminars, and demonstration sessions on beauty and wellness.
- To promote industry-academia linkage in the beauty and wellness sector.

3. ROLES AND RESPONSIBILITIES

Sakhi Makeovers shall:

- Provide professional training and practical exposure to students of GCW Hisar at its premises.
- Conduct workshops/demonstration sessions at GCW Hisar if required.
- Issue participation/training certificates to students upon successful completion of training.
- Ensure a safe and supportive learning environment during the training period.

GCW Hisar shall:

- Identify and enroll interested students in the training programs.
- Coordinate with Sakhi Makeovers for scheduling and monitoring of sessions.
- Extend necessary support in organizing awareness and promotional activities.
- Evaluate and certify the course/training as per academic norms.

4. DURATION

This MoU shall remain in effect for a period of Five (5) years from the date of signing and may be extended upon mutual agreement.

5. FINANCIAL TERMS: For the internship-related training program, the college shall bear no financial liability and will make no payments under any circumstances."

6. CONFIDENTIALITY

Both parties agree to maintain confidentiality of any proprietary or sensitive information shared during the course of this collaboration.

7. TERMINATION

Either party may terminate this MoU by providing a 30-day written notice to the other party. All existing commitments must be honored upon termination.
