MEMORANDUM OF UNDERSTANDING

And

Aryan Computer Education Society (Aryan Skill Center)
(Sector 14, Hisar, Haryana – 125001)

This Memorandum of Understanding (hereinafter referred to as the "MoU") is made and entered into on this 23rd day of MAY 2025, by and between: Government College for Women, Hisar, a premier educational institution affiliated with Guru Jambheshwar University of Science & Technology, Hisar], accredited by NAAC with Grade B located at Delhi Bypass Road, Hisar, Haryana – 125001.

AND

Aryan Computer Education Society (Aryan Skill Center), a registered society (Regn. No. HR/12/1115) having its office at First-Second Floor, Pocket-A, S.C.O. 106, Sector 14, Hisar, Haryana – 125001 .

Purpose:

The purpose of this MoU is to establish a framework of cooperation between the College and the Training Provider for organizing a **4 to 6 weeks/120 Hours Internship Training Programme** for **TDC-I students** from Arts, Commerce, and Science streams. The programme aims to enhance students' practical skills and industry exposure.

Scope of Collaboration:

1. Training Areas:

The Training Provider shall conduct training in the following areas:

- Data Entry Operations
- Tally – Accounting Assistant
- MS Office (Word, PowerPoint, Excel)
- Web Designing
- And any other Relevant domain where both parties mutually agreed upon.

2. Duration:

The internship will span **4 to 6 weeks**, amounting to a **minimum of 120 hours**.

3. Financial Arrangement:

The College shall bear **no financial liability** or make any payment towards the training programme.

4. Certification:

The Training Provider shall issue **certificates** to the participating students on successful completion of the internship, clearly stating the completion of **minimum 120 hours** of training.

5. Student Welfare & Safety:


The Training Provider shall ensure **discipline, safety, and security** of the girl students at all times during the training period.

6. Supervision & Monitoring:

The College shall appoint an **Internship Supervisor** to coordinate, monitor, and guide the students during the programme and to serve as a liaison between both parties.

Terms & Conditions:

- The programme shall be conducted in a **safe and secure environment**, adhering to professional decorum and discipline.
- Any form of misconduct or non-compliance with safety measures shall be treated as a breach of this MoU.
- This MoU does not create any legal or financial obligations beyond the scope of the internship training as mentioned herein.

Duration and Termination:

- This MoU shall come into effect from the date of signing and shall remain valid for **Five years**, unless terminated earlier by mutual consent in writing.
- Either party may terminate this MoU by giving **30 days' written notice** to the other party.

Dispute Resolution:

In the event of any dispute arising out of or in connection with this MoU, the parties shall endeavor to resolve the matter amicably through discussion and mutual agreement.
