purpose:

The purpose of this MoU is to establish a framework of cooperation between the College and the Training Provider for organizing a 4 to 6 weeks/120 Hours Internship Training Programme for TDC-I students from Arts, Commerce, and Science streams. The programme aims to enhance students' practical skills and industry exposure.

Scope of Collaboration:

1. Training Areas:

The Training Provider shall conduct training in the following areas:

- Data Entry Operations
- o Tally Accounting Assistant
- o MS Office (Word, PowerPoint, Excel)
- Web Designing
- o And any other Relevant domain where both parties mutually agreed upon.

2. Duration:

The internship will span 4 to 6 weeks, amounting to a minimum of 120 hours.

3. Financial Arrangement:

The College shall bear no financial liability or make any payment towards the training programme.

4. Certification:

The Training Provider shall issue certificates to the participating students on successful completion of the internship, clearly stating the completion of minimum 120 hours of training.

5. Student Welfare & Safety:

The Training Provider shall ensure discipline, safety, and security of the girl students at all times during the training period.

6. Supervision & Monitoring:

The College shall appoint an Internship Supervisor to coordinate, monitor, and guide the students during the programme and to serve as a liaison between both parties.

Terms & Conditions:

- The programme shall be conducted in a safe and secure environment, adhering to professional decorum and discipline.
- Any form of misconduct or non-compliance with safety measures shall be treated as a breach of this MoU.
- This MoU does not create any legal or financial obligations beyond the scope of the internship training as mentioned herein.

Duration and Termination:

This MoU shall come into effect from the date of signing and shall remain valid for Five years, unless terminated earlier by mutual consent in writing.

Either party may terminate this MoU by giving 30 days' written notice to the other

party.

Dispute Resolution:

In the event of any dispute arising out of or in connection with this MoU, the parties shall endeavor to resolve the matter amicably through discussion and mutual agreement.
