MEMORANDUM OF UNDERSTANDING

1. Purpose

This Memorandum of Understanding (MoU) is made and entered into on this 23rd day of MAY 2025, by and between **Techitute, Advertisers** a professional institute offering skill development courses, and **Government College for Women (GCW), Hisar**, with the objective of promoting skill-based education and enhancing employability through professional training in the fields of:

- Graphic Design
- Website Design
- Digital Marketing
- Functional Testing
- And other technology-driven courses as mutually agreed upon

2. Scope of Collaboration

Under this MoU, both parties agree to collaborate in the following areas:

- a) Offering certified training programs for students of GCW Hisar at subsidized or mutually agreed fees.
- b) Conducting workshops, webinars, and seminars for career guidance and industry exposure.
- c) Facilitating internship opportunities and project-based learning.
- d) Providing industry-oriented curriculum and experienced trainers.
- e) Supporting placement assistance for trained students.
- f) Issuance of joint certification (if applicable and agreed upon).

3. Roles and Responsibilities

Techitute- Advertisers shall:

- Provide certified trainers and updated course material.
- Conduct classes either on-campus or at Techitute's premises, as per convenience and agreement.
- Maintain discipline, quality, and structure in all training sessions.
- Provide certification to students on successful course completion.


GCW Hisar shall:

- Nominate a coordinator for communication and coordination.
- Facilitate student enrollment for the programs.
- Provide necessary infrastructure (if sessions are to be conducted on-campus).
- Promote and encourage student participation.

4. Financial Terms: For the internship-related training program, the college shall bear no financial liability and will make no payments under any circumstances."

5. Validity and Termination

- This MoU shall remain valid for a period of Five (5) years from the date of signing and can be extended upon mutual agreement.
- Either party may terminate this MoU with a prior written notice of 30 days, citing valid reasons.

6. Dispute Resolution

- Any dispute arising out of or in connection with this MoU shall be resolved amicably by both parties through mutual consultation. If unresolved, the matter shall be subject to the jurisdiction of courts in **Hisar, Haryana**.


7. Miscellaneous
