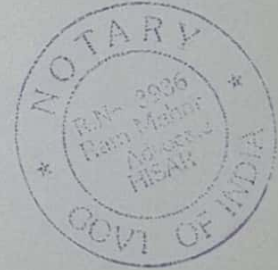

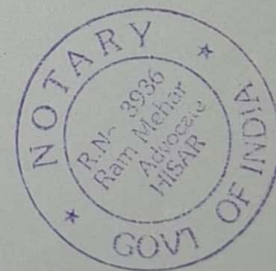
### 4. Roles and Responsibilities

#### 4.1 Responsibilities of Gramin Shiksha Private Limited

- The sharing of facilities shall be planned in advance and subject to availability and prior approval.

## 6. Duration of MoU

This MoU shall remain valid for a period of **five (5) years** from the date of signing. It may be renewed with mutual written consent of both parties.

## 7. Financial Terms

It is clearly agreed that **Government College for Women, Hisar shall not make any type of payment** to Gramin Shiksha Private Limited for internship training, skill development programs, workshops, seminars, or any other academic or professional activities conducted under this MoU.

If any fee is applicable for specific certification programs, the same shall be borne directly by the participating students as per mutually agreed terms.

## 8. Confidentiality

Both parties agree to maintain confidentiality regarding proprietary information, training materials, and institutional data shared during the collaboration.

## 9. Termination

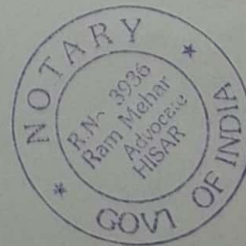
Either party may terminate this MoU by giving **30 days prior written notice**. However, ongoing programs shall be completed smoothly.
