1. Preamble

This Memorandum of Understanding (MoU) is made and entered into on this 6th day of April, 2026, by and between **Government College for Women (GCW), Hisar**, hereinafter referred to as "GCW", and **Divya Makerovers**, hereinafter referred to as "DMM".

Both parties recognize the importance of **skill-based education, vocational training, and experiential learning**, aligned with **NEP guidelines**, to enhance students' employability and entrepreneurial abilities in the beauty and wellness sector.

2. Objective of the MoU -

The primary objectives of this MoU are to promote:

- Internship and hands-on training as per NEP guidelines
- Skill-based education in beauty and salon management
- Industry-academia collaboration
- Development of professional competencies in beauty services
- Promotion of self-employment and entrepreneurship
- Enhancement of grooming, personality, and client-handling skills

3. Areas of Collaboration

The collaboration shall include **certificate-based internship training (4–6 weeks / approx. 120 hours)**, workshops, and skill development programs in the following areas:

- Basic and advanced beauty therapy techniques
- Hair care, styling, and treatment
- Skin care and facial treatments
- Makeup artistry (bridal, party, professional)
- Nail art and grooming services
- Salon management and customer handling
- Hygiene, safety, and professional ethics

Additional modules may be introduced with mutual consent.

4. Roles and Responsibilities

4.1 Responsibilities of Divya Makerovers

- Provide qualified trainers and beauty professionals
- Conduct certificate courses and internship training
- Provide necessary tools, products, and practical exposure
- Design structured modules for beauty and salon management
- Assess student performance and provide guidance
- Issue certificates to successful participants as per agreed norms

4.2 Responsibilities of Government College for Women, Hisar

- Identify and nominate eligible students
- Provide academic coordination and support
- Facilitate classroom/seminar space if required

- Ensure student discipline and participation
- Integrate training into skill/credit-based programs (if applicable)

5. Infrastructure Support

Both parties agree that:

- Training may be conducted at Divya Makeovers premises or GCW Hisar
- Necessary infrastructure including salon equipment, tools, and workspace shall be provided by Divya Makeovers
- Facilities shall be shared based on mutual planning

6. Duration of MoU

This MoU shall remain valid for a period of **five (5) years** from the date of signing. It may be renewed with mutual written consent.

7. Financial Terms

- Government College for Women, Hisar shall not make any direct payment to Divya Makerovers
- Any applicable training fee shall be borne by participating students as per mutually agreed terms

8. Confidentiality

Both parties agree to maintain confidentiality regarding training materials, student data, and institutional information.

9. Termination

Either party may terminate this MoU by giving **30 days prior written notice**. Ongoing programs shall be completed smoothly.

10. General Terms

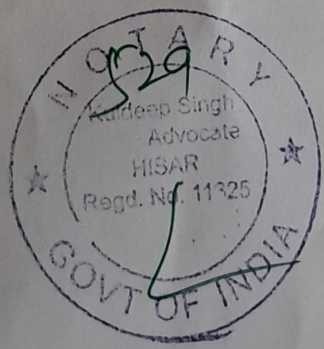
