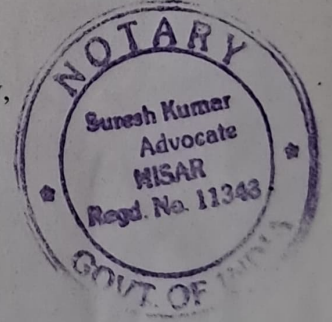

- **Vedic Mathematics**

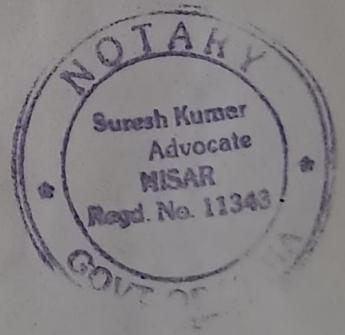
Additional programs may be introduced with mutual consent.

4. Roles and Responsibilities

4.1 Responsibilities of Aryavert Academy

- Conduct assessments, assignments, and evaluations.
- Issue certificates to successful participants as per agreed norms.

- Monitor student participation, attendance, and discipline.
- Integrate the program under credit-based internship (as per norms).

5. Infrastructure Support

Both parties agree that, based on mutual consent:

- GCW and Aryavert Academy shall provide infrastructural facilities such as classrooms, seminar halls, and basic teaching aids.
- Internship Training shall be conducted primarily offline, with optional online support (WhatsApp/Google Meet as per requirement).
- Infrastructure usage shall be planned in advance with prior approval.

6. Duration of MoU

This MoU shall remain valid for a period of five (5) years from the date of signing. It may be renewed with mutual written consent of both parties.

7. Financial Terms

It is clearly agreed that:

- Government College for Women, Hisar shall not make any payment to Aryavert Academy for conducting internship training, workshops, or related activities under this MoU.
- If any program fee is applicable, it shall be borne by the participating students, as per mutually agreed terms.

8. Confidentiality

Both parties agree to maintain confidentiality regarding training content, student data, and institutional information shared during the collaboration.

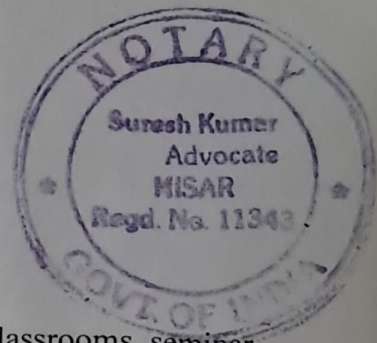
9. Termination

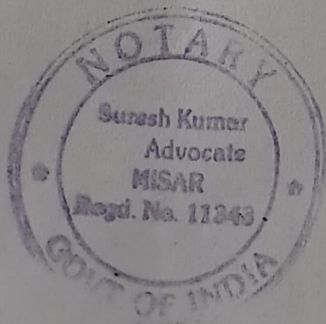
