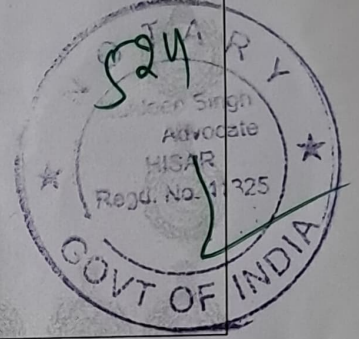

MEMORANDUM OF UNDERSTANDING (MoU)

1. Preamble

This Memorandum of Understanding (MoU) is executed on this 6th day of April, 2026, between **Government College for Women (GCW), Hisar** (hereinafter referred to as "GCW") and **V- Derma Beauty Academy & Clinic** (hereinafter referred to as "V-DBAC").

Both parties acknowledge the growing importance of **skill-based education, vocational training, and experiential learning**, in alignment with the **National Education Policy (NEP)**, to enhance employability, entrepreneurship, and professional competencies of students in the **beauty and wellness sector**.

2. Objectives of the MoU

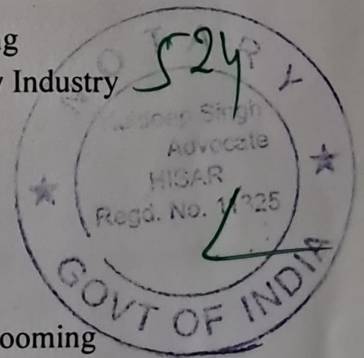
The objectives of this MoU are to promote:

- Internship and hands-on training in accordance with NEP guidelines
- Skill-based education in beauty, wellness, and salon management
- Industry–academia collaboration
- Development of professional competencies in beauty services
- Promotion of self-employment and entrepreneurship
- Enhancement of grooming, personality, and client-handling skills

3. Areas of Collaboration

The collaboration shall include **certificate-based internship training (4–6 weeks / approx. 120 hours)**, workshops, and skill development programmes in the following areas:

- Foundation Course in Skin Care, Hair Care, and Basic Makeup Techniques
- Hair Care, Styling, and Trichology Treatments
- Skin Care, Cosmetology, and Advanced Facial Therapies
- Professional Makeup Artistry (Bridal, Fashion, and Media Makeup)
- Nail Technology, Art, and Grooming Services
- Salon Operations, Management, and Client Relationship Handling
- Hygiene, Safety Standards, and Professional Ethics in the Beauty Industry
- Laser Technology and Aesthetic Treatments
- Ayurvedic Beauty and Wellness Therapies
- Panchakarma and Holistic Detoxification Techniques
- Wellness, Detox, and Rejuvenation Therapies
- Advanced Techniques in Beauty Therapy
- Behavioral Skills, Personality Development, and Professional Grooming



Additional modules may be introduced with mutual written consent of both parties.

4. Roles and Responsibilities

4.1 Responsibilities of V- Derma Beauty Academy & Clinic (V-DBAC)

- Provide qualified trainers and experienced beauty professionals

- Conduct certificate courses and internship training programmes
- Provide necessary tools, equipment, products, and practical exposure
- Design and deliver structured training modules
- Assess student performance and provide feedback and guidance
- Issue certificates to successful participants as per agreed norms

4.2 Responsibilities of Government College for Women, Hisar (GCW)

- Identify and nominate eligible students for training programmes
- Provide academic coordination and administrative support
- Facilitate classroom/seminar space, if required
- Ensure student discipline, attendance, and active participation
- Integrate training into skill/credit-based programmes, where applicable

5. Infrastructure Support

Both parties agree that:

- Training programmes may be conducted at the premises of V-DBAC or GCW, Hisar
- Necessary infrastructure, including salon equipment, tools, and workspace, shall be primarily provided by V-DBAC
- Facilities may be shared based on mutual planning and requirements

6. Duration of MoU

This MoU shall remain valid for a period of **five (5) years** from the date of signing and may be renewed with mutual written consent of both parties.

7. Financial Terms

- GCW, Hisar shall not bear any direct financial liability towards the training programmes
- Any applicable training fee shall be borne by participating students as per mutually agreed terms

8. Confidentiality

Both parties agree to maintain confidentiality of all training materials, student data, and institutional information shared during the course of this collaboration.

9. Termination



Either party may terminate this MoU by giving 30 (thirty) days' prior written notice. However, ongoing training programmes shall be completed in a smooth and mutually agreed manner.

10. General Terms and Conditions

- This MoU represents a statement of intent for academic and skill-based collaboration
- It does not create any legal partnership, joint venture, or employment relationship
- Any amendments or modifications shall be made in writing with mutual consent of both parti
