

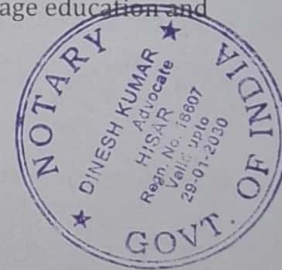
WHEREAS:

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:




1. Objectives of the MoU

- 1.1 To provide German language training programs to students.
- 1.2 To conduct structured preparation programs for German language proficiency exams such as Goethe and TELC.
- 1.3 To enhance students' global employability, communication skills, and cultural awareness.
- 1.4 To promote academic-industry collaboration for international career opportunities and exposure.

2. Roles and Responsibilities

GCW Hisar shall:

- 2.1 Facilitate student enrollment and awareness for the programs offered.
- 2.2 Provide necessary infrastructure support such as classroom space and basic facilities, as required.
- 2.3 Assist in coordination, scheduling, and monitoring of the programs conducted.

MOSA shall:

- 2.4 Design and deliver curriculum for German language training programs.
- 2.5 Provide qualified trainers and study material.
- 2.6 Prepare students for Goethe and TELC examinations (ncertification will be issued by MOSA).
- 2.7 Provide guidance related to international career opportunities, including awareness sessions, seminars, and workshops.
- 2.8 Maintain academic and training records and submit periodic reports to GCW Hisar.

2.9 Areas of Interest:

- Foreign Languages - German - French - Japanese - Spanish - Spoken English.
- Internship (4 weeks) (optional)
- Paid Placement Support for Germany and Japan.

3. Duration and Termination

- 3.1 This MoU shall remain in force for a period of five (5) years from the date of signing and may be extended by mutual written consent.
- 3.2 Either party may terminate this MoU by giving one month's prior written notice to the other party.

4. Confidentiality

- 4.1 Both parties agree to maintain confidentiality of all proprietary or sensitive information exchanged during the course of this MoU.


5. Dispute Resolution
